

SALES TAX COMPARISON OVERVIEW

October 2023 versus October 2024 Analysis

The City's state sales tax collections payment for October 2024 was \$2,108,358 or \$158,236 <u>less</u> in revenue than the same time last year. On page 4, you will see a table that shows the variations by category of more than \$15,000 in sales taxes collected in Laramie County, comparing October 2023 to October 2024.

The most significant sales tax differences year-over-year that are greater or less than \$100,000 are as follows:

- ♠ Building Material and Supplies Dealers. Sales tax for this industry increased by \$410,920 in October 2024 compared to the same time last year. This industry group comprises establishments primarily engaged in retailing new building materials and supplies.
- ↑ Nonresidential Building Construction. This industry group comprises establishments primarily responsible for the construction (including new work, additions, alterations, maintenance, and repairs) of nonresidential buildings. Sales tax for this industry increased by \$169,403 compared to October 2023.
- ↑ Other Miscellaneous Store Retailers. Sales tax for this industry increased by \$132,008 in October 2024. This industry group comprises establishments primarily engaged in retailing new miscellaneous specialty store merchandise (except motor vehicle and parts dealers; furniture and home furnishings stores; consumer-type electronics and appliance stores; building material and garden equipment and supplies dealers; food and beverage stores; health and personal care stores; gasoline stations; clothing and clothing accessories stores; sporting goods, hobby, book, and music stores; general merchandise stores; florists; office supplies, stationery, and gift stores; and used merchandise stores).
- ↑ Executive, Legislative and General Government. This industry group is primarily used by governments including Laramie County to report sales and use tax collections on all vehicle purchases, except motorcycles, obtained from a Wyoming dealer. Sales tax for this industry increased by \$102,019 compared to the same time last year.
- Support Activities for Mining. This industry has continued to decline into the second quarter of the fiscal year. In the month of October, revenues decreased by \$1,638,046. This industry comprises establishments primarily providing support services, on a contract or fee basis, required for the mining and quarrying of minerals and for the extraction of oil and gas. Establishments performing exploration (except geophysical surveying and mapping) for minerals, on a contract or fee basis, are included in this subsector. Exploration includes traditional prospecting methods, such as taking core samples and making geological observations at prospective sites.
- Machinery and Equipment Rental and Leasing. This industry group comprises establishments primarily engaged in renting or leasing commercial type and industrial type machinery and equipment Establishments included in this industry group are generally involved in providing capital or investment type equipment that clients use in their business operations. Sales tax for this industry decreased by \$169,756 compared to the same time last year.
- ◆ Electric Goods Merchant Wholesalers. Sales tax for this industry decreased by \$106,607 in October 2024. This industry group comprises establishments primarily engaged in the merchant wholesale distribution of electrical apparatus and equipment wiring supplies and related equipment household appliances electric housewares and consumer electronics and other electronic parts and equipment.
