## **AGENDA ITEMS**

18. ORDINANCE -2<sup>nd</sup> READING - Amending Chapter 2.16.010 of the Municipal Code of the City of Cheyenne, Wyoming, requiring the City Treasurer to annually evaluate and report to the Governing Body any outstanding debt owed the City by any City Board, Council or Commission Member. (SPONSORS - DR. ALDRICH, MR. COOK AND MR. JOHNSON)

Mr. Cook moved to approve on 2<sup>nd</sup> reading, seconded by Mr. Johnson. Motion carried by unanimous voice vote.

Ward III Councilman, Richard Johnson, and sponsor of the item, provided an overview of the proposed ordinance. Mr. Cook and Mr. White thanked John Brodie, Deputy City Attorney, for his work on the ordinance and the sponsors for bringing it forward.

24. RESOLUTION – Authorizing a one-time payment from Fiscal Year 2024 budget savings given to full-time and permanent part-time employees of the City of Cheyenne (excluding elected officials and employees of the Cheyenne Board of Public Utilities). (SPONSOR – DR. ALDRICH)

Mr. Cook moved to adopt, seconded by Mr. Johnson. Mr. Cook moved to amend by substitute dated November 21, 2024, seconded by Mr. Johnson. Motion to amend carried by unanimous voice vote. Main motion, as amended, carried by unanimous voice vote.

Robin Lockman, City Treasurer, provided a staff report and Mayor Patrick Collins provided additional information. Chairwoman Aldrich provided information related to the substitute and committee members Johnson and White commented on the item. Public comment was made by Seth Lloyd, City employee.

  - c) Consideration of Bid #S-7-25 for an Agreement between the City of Cheyenne and Fencetrak Inc. d/b/a Full Tilt Services for the Belvoir Ranch Trailhead and Access Roads Project. (Belvoir Ranch Recreation Fund and Wyoming Outdoor Recreation Grant)

Mr. Cook moved to accept the bid in an amount not to exceed \$672,507.50, seconded by Mr. Johnson. Motion carried by unanimous voice vote.
