6. ORDINANCE –2nd READING – Amending various sections of Chapter 15.08, 15.09, 15.10, 15.12, 15.16, 15.22, 15.24 and 15.26 of Title 15, Buildings and Construction, of the Municipal Code of the City of Cheyenne, Wyoming, updating specified Building Code requirements and making technical corrections as further specified. (SPONSOR – MR. SEGRAVE)

Dr. Aldrich moved to approve on 2nd reading, seconded by Mr. White. Motion carried by unanimous voice vote.

Antony Pomerleau, Chief Building Official, provided a staff report. John Brodie, City Attorney and Tom Cobb, City Engineer, provided additional information. Committee members Aldrich, Emmons, and White commented on the item. Public comment was made by Michael White.

7. ORDINANCE –2nd READING – Amending various sections within Chapter 8.12, International Fire Code adopted, of Title 8, Health and Safety, of the Municipal Code of the City of Cheyenne, Wyoming, updating the edition of the International Fire Code adopted by the City and further amending as specified. (SPONSOR – MR. SEGRAVE)

Mr. White moved to approve on 2nd reading, seconded by Dr. Emmons. Motion carried with Dr. Emmons and Mr. White voting “YES” and Dr. Aldrich voting “NO.”

Bob Mason, Fire Marshal, Fire Rescue Department, provided a staff report. Committee members Aldrich, Emmons, and White commented on the item. Public comments were made by Travis Spears, The Electric & Solar Specialist, and Michael White.


8. ORDINANCE –2nd READING – Amending section 8.24.020 of the Municipal Code of the City of Cheyenne, Wyoming, clarifying and further regulating the installation of above-ground tanks and containers as specified. (SPONSOR – MR. SEGRAVE)

Mr. White moved to approve on 2nd reading, seconded by Dr. Emmons. Motion carried by unanimous voice vote.

Bob Mason, Fire Marshal, Fire Rescue Department, provided a staff report. Chairman Segrave and committee members Aldrich and Emmons commented on the item.
