

ORDINANCE NO. _____

ENTITLED: “AN ORDINANCE AMENDING SECTION 2.76.020, MEMBERS–TERM–VACANCIES, OF CHAPTER 2.76, DOWNTOWN DEVELOPMENT AUTHORITY, OF TITLE 2, ADMINISTRATION AND PERSONNEL, OF THE CODE OF THE CITY OF CHEYENNE, WYOMING.”

BE IT HEREBY ORDAINED BY THE GOVERNING BODY OF THE CITY OF CHEYENNE WYOMING:

Section 1. That Section 2.76.020, Members–Terms–Vacancies, of Chapter 2.76, Downtown Development Authority, of Title 2, Administration and Personnel, of the code of the City of Cheyenne, Wyoming, is hereby amended as set out in this ordinance. Provisions currently existing in Chapter 2.76 not set out within this ordinance remain unchanged.

Section 2.76.020 Members–Terms–Vacancies.

A. The reorganized authority shall consist of newly appointed board members numbering not less than five nor more than eleven (11) members appointed initially by the Mayor and subsequently by the governing body. The affairs of the authority shall be under the direct supervision and control of a the board ~~consisting of ten (10) members appointed by the mayor with the advice and consent of the governing body.~~ A majority of the members, ~~except any member from the governing body,~~ shall reside, be a lessee or own property in the downtown development district.

B. The board shall be constituted as follows:

1. At least one member shall be a member of the governing body appointed to serve at the pleasure of the governing body;

2. ~~Nine members shall be appointed by the mayor in accordance with the by-law of the downtown development authority.~~ The remaining members shall be appointed to staggered terms in accordance with Wyo. Stat. Section 15-9-205(b).

C. A member shall hold office until his or her successor has been appointed and qualified. After the terms of the initial members have expired, the terms of all members, except the appointed member of the governing body, shall expire four years from the expiration date of the terms of their predecessors. Appointments to fill vacancies shall be for the unexpired term, and shall be made within thirty (30) days after the occurrence of the vacancy.

D. Board members shall serve without compensation, but may be reimbursed for actual and necessary expenses.

E. If the board enters into a cooperative agreement with any other entity to carry out all, or any part, of its duties, a positive vote of a majority of the members in attendance at any meeting of the cooperative shall be required on all matters affecting the statutory authority of the board.

Section 2. That this ordinance shall be in full force and effect upon its approval and publication.
